# OMSA Extraordinary General Body Resolutions

### HELD ON 10.11.2013 AT- I.M.A. HOUSE, BHUBANESWAR (To be circulated among OMSA members)

All CWC Members / Branch Secretary / Branch President / OMSA Members / CDMO's / SDMO's

Sir / Madam,

I am directed by General Body of OMSA to communicate the following resolutions passed in the Extraordinary G.B. meeting of OMSA held on 10.11.2013 at I.M.A. house, Bhubaneswar.

**Resolution No.1** - It is resolved unanimously to appeal to the Hon'ble Chief Minister of Odisha to implement DACP (Dynamic Assured Career Progression) for OMS Cadre Doctors without delay as it is already delayed since the formation of three ministerial (Health, Law, Finance) Committee to look into its on March 2010, to encourage young medicos to take up a career in OMS Cadre and there by filling up large vacancies in order to provide basic health care to ailing population of Odisha.

**Resolution No.2** - It is resolved unanimously to strongly oppose the extension of retirement age of OMS Cadre doctors beyond 60 yrs of age as it will serve no purpose and will be wastage of public money as evident from the result of increasing retirement age from 58 yrs to 60 yrs few years back. If Govt. raises the retirement age, the members will resign enmasse.

**Resolution No.3** - It is resolved unanimously to urge to the Hon'ble Chief Minister of Odisha to implement a Transparent Transfer Policy for OMS Cadre doctors immediately as it has zero financial implications and will drive out corruption, nepotism, favoritism from the Health Sector and allow the member to work in a congenial atmosphere without fear or favour and also prevent absenteeism from work place.

**Resolution No.4 -** It is resolved unanimously to request the Hon'bel Chief Minister and Health Minister of Odisha to withdraw proceedings against all members and regularize one day stoppage of salary on 18/04/10 due to Mass Agitation sponsored by Association to achieve its long standing demands.

**Resolution No.5** - It is resolved unanimously to appeal o the Hon'ble Chief Minister of Odisha not to post any corrupt Health Official in Administrative posts as it is the policy of Association of "Zero tolerance to corruption" and also conduct speedy enquiry and action against them to weed out corruption from Health Sector.

**Resolution No.6** - It is resolved unanimously to reinstate those OMSA members who were previously expelled by OMSA General body dated 25/7/2010 & 21/11/2010 on revocation of previous resolutions in the larger interest of the association.

**Resolution No.7 -** It is resolved to dissolve the action committee which was formally formed some days ago and any collection of money in the name of OMSA action committee is hereby declared illegal.

**Resolution No.8 -** It is resolved unanimously to purchase land allotted by GA Dept. to OMSA, for construction of OMSA Bhawan by paying the rest amount of money from OMSA account and also to construct barbed ware-fencing around the plot from OMSA account.

**Resolution No.9 -** It is resolved unanimously to collect Rs. 1000/ (Rupees One Thousand Only) from each OMSA member for management of day to day routine affairs of OMSA.
