Sub- inaction of The District Police Administration of Puri regarding, assault on a Govt. Doctor, while on duty.

Sir,

I have the regards to put forth the following facts before you on behalf of the Odisha Medical Services Association (OMSA).

One Dr Subha kanta Ojha of the District Headquarter Hospitals Puri, while discharging duties in the OPD at about 3 pm on 02.03.2014 was brutally assaulted by a group of antisocial people. The doctor, at that time was busy catering health Services to a large crowd. The said antisocial elements present in the crowd demanded Immediate X Ray of the patient which could not be done. After a while the crowd came back with more people and thrashed the doctor citing negligence of duty. One of the hooligans was brandishing a gun. The said crowd was headed by a local MLA's representative. FIRs have been lodged against the culprits by Dr. Ojha and the Chief District Medical Officer, Puri on 02.03.2014. No action has yet been initiated in this regard.

The doctors' community at DHH Puri feel unsafe to discharge their duties.

We therefore request you to kindly take steps to nab the culprits immediately in the larger interest of the Public or else the doctors under the banner of OMSA Shall resort to cease work with immediate effect.
