RESOLUTION 12:



RESOLUTIONS OF GENERAL BODY OMSA

Held on dt. 06/9/2015 at IMA House Bhubaneswar

RESOLUTION 1:

It is unanimously resolved to request Hon'ble Chief Minister, Odisha to pass an order of implementation of DACP(Dynamic Assured Career Progression)and other benefits for OMS Cadre doctors at par with Central Govt Health Services as this is the legitimate and long pending demand of OMSA. DACP(Dynamic Assured Career Progression) has already been awarded for Govt. Doctors in all central Govt. health sectors since 2006 as per 6th Pay Commission revision and later on 12 States have followed the path of implementation of DACP.
