Date of counting of votes : Immediately after completion of polling on 08.03.2015.



Sub: Guidelines for election of OMSA 2015-17.


Madam/Sir,

The guidelines for OMSA 2015-17 is as follows:

- All the SDMOs are declared as presiding officer-cum-returning officer of their branches.
- All ADMO (Med.) are declared as presiding officer of district and CDMOs are returning officer of the district.
- Superintendent of Capital Hospital, Bhubaneswar and CMO, RGH, Rourkela are declared as returning officer and Dy. Suptd. are decaled as presiding officer.
- The valid members of 3 Medical Colleges are requested to cast their votes in the adjacent district headquarter branch.
- Voting will be done in the ballot boxes in respective branches with in 10 am to 5pm on 08/03/2015.
- The individual ballot will be signed by the presiding officer and returning officer. Also the voter will sign in the space designated.
- After voting the returning officer will count the votes from tick marks marked against candidates.
- The valid and invalid votes with unused ballot papers along with the counter foils will be returned back to the Convener, CEC within 3 days along with the proforma provided (along with the ballot paper).
- The returning officers are requested to intimate the CEC by SMS/E-mail given in the ballot paper on the same day.
