Subject:- Resolution of OMSA condemning the letter issued from your office regarding health facility verification.

Respected Sir,

With due respect, this is to bring to your kind notice that the Odisha Medical Services Association (OMSA), in its state executive meeting held on 23rd August 2025, has taken strong exception to the letter issued from your office vide Office Order No. S/15193, Dated 21.08.2025 regarding verification of health facilities in Jagatsinghpur district.

The OMSA CWC meeting unanimously passed a resolution condemning the high-handedness reflected in the said order and also expressed concern over the perceived ineffectuality of the district medical administration being implied therein.

Internal and open discussions held among OMSA members of Jagatsinghpur district and the OMSA State President & all Executives revealed widespread displeasure across the district and the state. Members collectively view the nature and tone of the letter as not only harassing the doctors, but also demeaning our departmental administrators, as if they are being treated as null. If it is truly felt that our own departmental administrators are not capable, then the appropriate step would be to kindly notify the Government, but not to involve other departments to oversee or intrude upon the functioning of the Health Department.
