8- It is also decided that frequent press meet at state level will be do.


9- It is also decided that life memberships drive and Omsa Bhawan collection continue simultaneously.

DEMANDS OF OMSA

1-DACP as per CGHS pattern to both OHMS & Dental cadres with the completion of years of service of 4-9-13 -20 corresponding to 7th pay commission col-13 -14-16-17 without in pre service condition which is mentioned in sl no-3 of DACP Notification no- 9179/H /HFW-MSIIAESTT-0008-2023 on dated 20/04/2024. Adhoc service period may be considered towards the sanctions of DACP.

2-DACP must be implemented from date of eligibility month of Qualifying year which is contradictory in slno—5 I n above notification.

3-Restructuring of OMHS cadres may be revised (Whose proposal submitted by Omsa) as cadres strength increased from 6719 to 15774. *Dental cadres restructuring proposal also submitted by comedra*

4-Implementation of exit policy (TTP) is to be carried out for OMHS cadres in transfer season of each year, special attention must be given who have completed more than 5yrs in kbk ,kbk+ and tsp areas. They must be transfer to their preferable place.

5- Below CDM&PHO rank DPC was not done since 2019 , also DPC done in 2019 not posted till now ,AD rank medical officers are working in CHC level. So regular DPC must be done for each category of cadres ,for which disharmony of positions of cadres will be not there.

6-The Dental surgeons may be allowed to avail place base & PG incentives. CDM&PHO may be allowed to fill up vacancy of Dental surgeons on contractual basis.

7-The incentives of PG, Super Speciality ,Diploma holders & post-mortem allowances may be enhanced proportionately. M.B.B.S. Doctors are in Administrative post must be given administrative allowance

8-The Reporting officers of PAR of CDM&PHOs may be assigned to DHS.


9-Capital Hospital Bhubaneswar comprising of all Discipline is a premier hospital of the state. The PG courses of PGIMER is collocated here. We

request PGIMER may be relocated to other convenient place of Bhubaneswar.

10-the Medical officers of peripheral institutions of state have no residential Quarters or if present, it is very worst conditions and no regular repair or renovation.it is very difficult to get a rented house in remote area of kbk ,kbk+ and tsp areas .so govt should look into this matters urgently.
