CWC RESOLUTION OF OMSA ON DT. 07.08.2015 AT IMA HOUSE, BHUBANESWAR.

Resolution-1 It is resolved unanimously to request Hon'ble Chief Minister Odisha to implement DACP (Dynamic Assured Career Progression) which has been awarded by 6th Pay Commission soon for OMSA Cadre Doctors as it has already been implemented by 12 other states of Indian Union. It is resolved to give heartfelt thanks to Hon'ble Chief Minister Odisha, who has constituted a high Power Ministerial Committee Consisting of Hon'ble Minister Finance, Health & Law to implement DACP (Dynamic Assured Career Progression) and to request to interfere in the matter and to instruct the ministerial committee to submit the report with their findings as quick as possible since 5 years have already elapsed.

Resolution-2 It is unanimously resolved to press for the demand of OMS cadre restructuring i.e. Pay band parity in the higher posts with State Govt. Officers. Around 550 Posts (i.e. 10% of cadre strength) of Pay band-4 should be created for OMSA Cadre doctors, as proposed by OMSA.

Resolution- 3 It is unanimously resolved to make all Adhoc doctors permanent by regular OPSC recruitment, by way of validation or any procedure, so that young doctors will be attracted towards Odisha Govt. Health Services and vacancies will be filled up permanently.

Resolution- 4 It is unanimously resolved to fix the date for general body meeting of OMSA on 06.09.2015 tentatively. It is a Sunday. propose is to discuss all OMSA demands. All members are requested to attend this G.B. Meeting positively to show our strength.


