# Before Hon'ble Chief Minister, Odisha - Prayer for discussion with State Executives of OMSA

Hon'ble Sir.

On behalf of OMSA, we the members draw your kind attention the following few lines for your kind consideration and favorable order. It is pertinent to mention here that for so many years in the past, the Govt. had not taken any steps for re-dressal of the grievances of association which has been fulfilled partially in the recent past taking into consideration "Doctors as Special Category" by Hon'ble present Chief Minister of Odisha.

We the member of OMSA requests you to full fill our following genuine demands in the interest of public and association.

- 1. Implementation of DACP (Time Scale Promotion) and other benefits to OMS cadre doctors as per Central Govt. Health Services.
- Implementation of Draft proposal of OMSA on CADRE RE-STRUCTURING OF OMS CADRE after discussion with state executive of OMSA at an early date.
- Regular recruitment of Doctors into OMS cadre through OPSC (Odisha Public-Service Commission) and regularization of service of ADHOC Doctors already working in Health Department by the process of validation
- 4. Creation of Medical Officer (Jr. Cl-I rank) post in SDH, CHC, AH, Medical Colleges, Capital Hospital and RGH as created recently in DHH by the Govt.
- 5. Transparent Transfer policy.
- Administrative allowance and Specialist allowance @ 30% of the Basic Pay with usual DA to Doctors holding the administrative and Specialist post.
- Post Graduation Study period should be considered as in service on deputation.
- Seven Zonal Hospital equivalent to Capital Hospital & RGH Rourkela may please be established at Angul, Baripada, Balasore, Bolangir Jeypur, Phulbani and Puri.
- Creation of Diploma / Short term Course in FMT, Anesthesia, Paediatrics, Surgery, Medicine, Pathology, Radiology, Orthopedics, TB & Chest, Eye & ENT etc in Medical Colleges of Odisha.

Administrative and Financial Training to OMS Cadre Doctors.

We, hence, request your Hon'ble self to be gracious enough to kindly fix a date for discussion with State Executive Committee of OMSA only authorized body for discussion on the aforesaid demands of the association in the interest of public and association for smooth and proper delivery of Health care service to people of Odisha and obliged.
